# **PARTICIPANT REGULATIONS**

#### 1. VENUE AND DATE

The I World Copper Conference will be held on May 29, 30, 31 and June 1, 2023 at the Centro de Exposiciones Jockey Club del Perú, located at: Av. Javier Prado Este (Intersection with Carretera Panamericana S/N, Puerta 1, Hipódromo de Monterrico Parcela 1) - Santiago de Surco, Lima.

#### 2. PARTICIPANTS
